

“RESOLUTION APPROVING AND ADOPTING THE CY 2026-2028 LOCAL DEVELOPMENT PLAN FOR CHILDREN (LDPC) AND ITS CORRESPONDING CY 2026-2028 LOCAL INVESTMENT PLAN FOR CHILDREN (LIPC) OF THE MUNICIPALITY OF BAROBO, SURIGAO DEL SUR, AS ENDORSED BY THE MUNICIPAL DEVELOPMENT COUNCIL, AND INCORPORATING THE SAME INTO THE SECTORAL PLANS OF THE MUNICIPALITY”

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the *Local Government Code of 1991*, provides that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance and those essential to the promotion of the general welfare;

WHEREAS, Section 106 of the same Code provides for the creation of the Local Development Council which shall assist the Sanggunian in setting the direction of economic and social development and coordinating development efforts within its territorial jurisdiction;

WHEREAS, consistent with the policy of the State to promote and protect the rights and welfare of children and ensure child-responsive governance, local government units are encouraged to formulate and implement plans, programs, projects, and activities supportive of children's welfare and development;

WHEREAS, the Municipal Development Council (MDC) of the Municipality of Barobo, through **MDC RESOLUTION NO. 01, S. 2026**, approved, adopted, and endorsed to the Sangguniang Bayan the CY 2026-2028 Local Development Plan for Children (LDPC) and its corresponding CY 2026-2028 Local Investment Plan for Children (LIPC), and recommended the incorporation of the same into the sectoral plans of the Municipality of Barobo;

WHEREAS, the aforesaid MDC Resolution was first deliberated during the Regular Session of the Sangguniang Bayan of Barobo held on April 14, 2026 and, after due deliberation, the same was referred to the Committees on Finance and Planning for further committee consideration;

WHEREAS, accordingly, the Committees on Finance and Planning conducted a committee meeting on May 6, 2026 to discuss and evaluate the proposed plans and their corresponding implementation framework;

WHEREAS, after careful review and thorough deliberation, the Sangguniang Bayan of Barobo, assembled in session on May 12, 2026, found the necessity and propriety of approving and adopting the CY 2026-2028 Local Development Plan for Children (LDPC) and its corresponding CY 2026-2028 Local Investment Plan for Children (LIPC) in order to strengthen child-focused governance and ensure the integration of child-responsive programs into the municipality's development agenda.

NOW, THEREFORE:

BE IT RESOLVED, by the Sangguniang Bayan of Barobo, Surigao del Sur, *to*:


