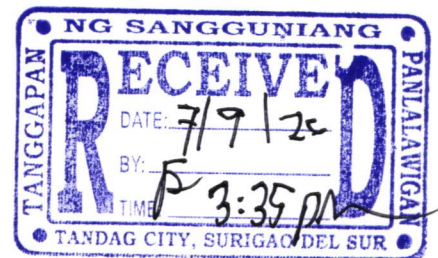

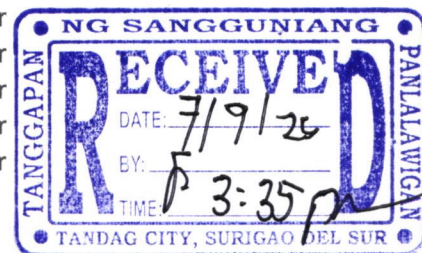

EXPLANATORY NOTE

WHEREAS, Section 21 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991, empowers Local Government Units to temporary close national or local roads during athletic, cultural or civic activities or for any other lawful public purposes;



WHEREAS, the late Mr. Simplicio Cruda was a respected, deeply loved, a long- standing resident of this municipality and a former hired emergency workers under the Office of the Municipal Engineer for so many years and the passing has brought profound grief and sorrow to his family, friends and neighbors;

WHEREAS, the bereaved family humbly requested the temporary closure of a portion of Bomediano Street, Barangay Poblacion to provide a dignified, sacred and safe space where the community can gather to offer final prayers, pay their last respects and comfort the family;

WHEREAS, the expected outpouring of sympathy from numerous relatives, friends and community members necessitates an expanded area for the wake to ensure safety, comfort and orderly movement of all mourners;

WHEREAS, it is a time- honored Filipino tradition and a core value of the Municipality of Carmen, Surigao del Sur to show Bayanihan and deep solidarity with its constituents during moments of deepest bereavement and loss;

BE IT ORDAINED, by the Sangguniang Bayan of Carmen, Surigao del Sur in session assembled, that:

SECTION 1. TEMPORARY ROAD CLOSURE- The temporary closure of a portion Bomediano Street, Barangay Poblacion, Carmen, Surigao del Sur is hereby authorized starting July 7, 2026 specifically to accommodate the funeral wake and related activities for the late Mr. Simplicio Cruda.

SECTION 2. DATE AND TIME OF TERMINATION- The temporary road closure authorized under this Ordinance shall officially terminate at 11:59 P.M. on July 17, 2026. Immediately upon termination, all structures, rents, chairs and barricades shall be cleared and the road shall be fully reopened to normal vehicular traffic.

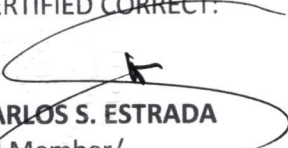
SECTION 3. TRAFFIC REROUTING AND MANAGEMENT- The Municipal Disaster Risk Reduction and Management Office (MDRRMO), the Local PNP, BPATS of Barangay Poblacion shall jointly implement a traffic rerouting plan, clear directions signs, advisory notices and barricades must be installed at strategic entry and exit points to guide motorists to alternate route;

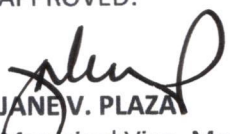
SECTION 4. EFFECTIVITY- This Ordinance shall take effect immediately upon its approval.
