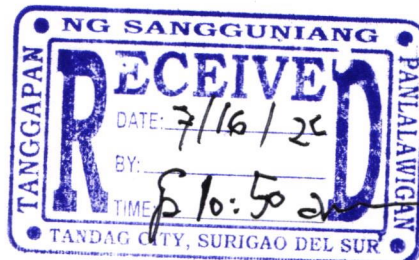

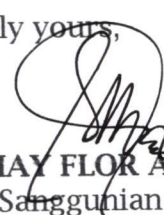

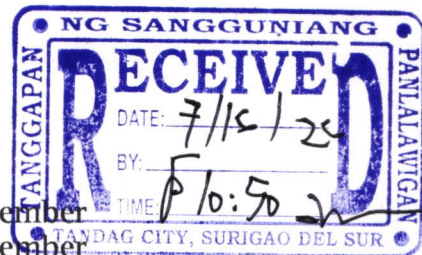

"RESOLUTION INFORMING THE SANGGUNIANG PANLALAWIGAN OF SURIGAO DEL SUR OF THE EXISTING ORDINANCES OF THE MUNICIPALITY OF BAROBO IN COMPLIANCE WITH DILG MEMORANDUM CIRCULAR NO. 2026-029 AND SP RESOLUTION NO. 1117-26, SERIES OF 2026, REQUESTING THE PHILIPPINE NATIONAL POLICE (PNP), MUNICIPAL SOCIAL WELFARE AND DEVELOPMENT OFFICE (MSWDO), AND OTHER CONCERNED OFFICES TO STRICTLY ENFORCE THE SAME, AND FURTHER INFORMING THAT THE PROPOSED ORDINANCE PROHIBITING BEING TOPLESS OR HALF-NAKED IN PUBLIC PLACES IS CURRENTLY UNDER FORMULATION"

WHEREAS, the Sangguniang Panlalawigan of Surigao del Sur enacted SP Resolution No. 1117-26, Series of 2026 - *encouraging all local government units in the province to enact local ordinances under the "Safer Cities: A Call to Action for Local Government Units" initiative in compliance with DILG Memorandum Circular No. 2026-029 dated April 8, 2026;*

WHEREAS, DILG Memorandum Circular No. 2026-029 encourages local government units to enact ordinances addressing public safety and order, particularly on the prohibition of consumption of alcoholic beverages in public places, prohibition against being topless or half-naked in public places, regulation of videoke machines and other amplified audio devices, and the imposition of curfew on minors;

WHEREAS, upon review of existing local legislation, the Municipality of Barobo has already enacted ordinances substantially addressing three (3) of the identified policy areas, namely:

1. **Ordinance No. 03, Series of 2019** - *"An Ordinance Prohibiting the Consumption or Drinking of Beer, Wine, Liquor or Similar Intoxicating Beverages in Public Places and Providing Penalties for Violations Thereof";*
2. **Ordinance No. 03, Series of 2018** - *"An Ordinance Regulating the Sounds of Videoke, Karaoke, and Other Forms of Commercial Bars Using Amplified Equipment that Causes Unnecessary Disturbances to the Public";*
3. **Ordinance No. 03, Series of 2003** - *"An Ordinance Prohibiting Minors to Roam Around During Nighttime and Providing Penalties for Violations Thereof," the pertinent provisions of which have likewise been incorporated under Article XI of Ordinance No. 27, Series of 2020, otherwise known as the "Child and Youth Welfare Code of the Municipality of Barobo";*

WHEREAS, with respect to the proposed ordinance prohibiting persons from being topless or half-naked in public places, the Sangguniang Bayan is presently undertaking the necessary legislative measures for the formulation and consideration of an appropriate local ordinance consistent with applicable laws, public decency standards, and local circumstances;

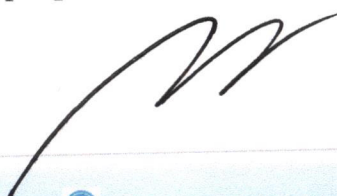
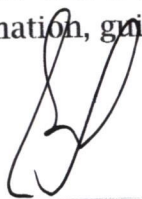
WHEREAS, while the foregoing ordinances are already in place, their effective implementation and enforcement remain essential in advancing public order, discipline, and safety, as aligned with the objectives of the Safer Cities campaign.

NOW THEREFORE:

BE IT RESOLVED, by the Sangguniang Bayan of Barobo, Surigao del Sur *to*:

INFORM THE SANGGUNIANG PANLALAWIGAN OF SURIGAO DEL SUR OF THE EXISTING ORDINANCES OF THE MUNICIPALITY OF BAROBO IN COMPLIANCE WITH DILG MEMORANDUM CIRCULAR NO. 2026-029 AND SP RESOLUTION NO. 1117-26, SERIES OF 2026; REQUEST THE PHILIPPINE NATIONAL POLICE (PNP), MUNICIPAL SOCIAL WELFARE AND DEVELOPMENT OFFICE (MSWDO), AND OTHER CONCERNED OFFICES TO STRICTLY ENFORCE THE SAME, AND FURTHER INFORM THAT THE PROPOSED ORDINANCE PROHIBITING BEING TOPLESS OR HALF-NAKED IN PUBLIC PLACES IS CURRENTLY UNDER FORMULATION

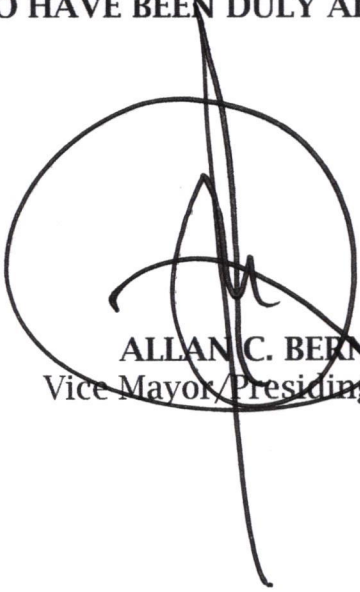
