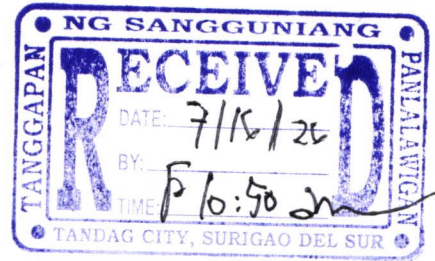

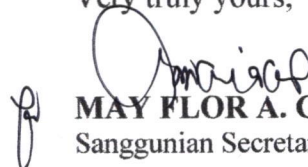

WHEREAS, the Municipal Disaster Risk Reduction and Management Council (MDRRMC) passed MDRRMC RESOLUTION NO. 2, S. 2026 entitled: “RESOLUTION APPROVING AND ENDORSING TO THE MUNICIPAL DEVELOPMENT COUNCIL (MDC) THE SUPPLEMENTAL AIP NO. 1 FOR CY 2026 AMOUNTING TO PHP21,000,000.00 OF BAROBO”;

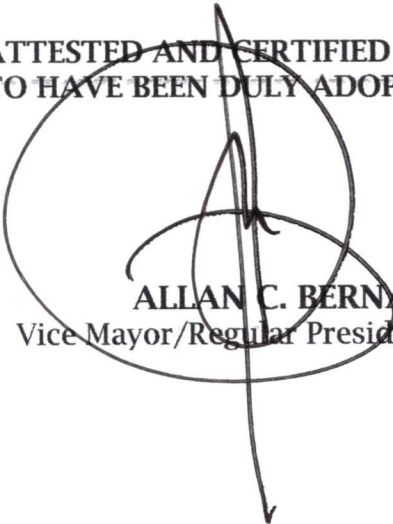

WHEREAS, Section 107 of RA 7160, otherwise known as the Local Government Code (LGC) of 1991 provides for the composition of a multi-sectoral body known as the Local Development Council (LDC) which is tasked to assist the Sangguniang Bayan in setting the direction of the economic and social development and coordinates the development efforts of the municipality;

WHEREAS, the rising incident of calamities all over the world has prompted the Philippine Government to pass Republic Act 10121, otherwise known as the “Philippine Disaster Risk Reduction and Management Act of 2010;

WHEREAS, under section 12 of the said act, the Local Disaster Risk Reduction and Management Officer is required to prepare and submit to the Sangguniang Bayan through the

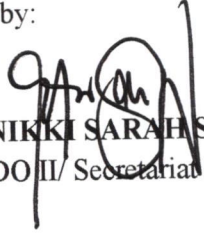

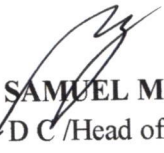

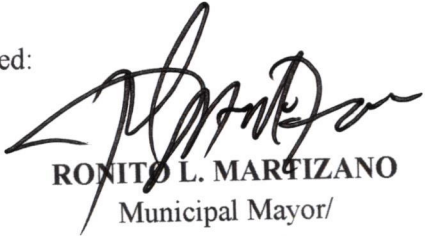
