RESOLVED FURTHER, that copies of the Resolution be furnished to the Provincial Government of Surigao del Sur and all concerned offices for their information and guidance.

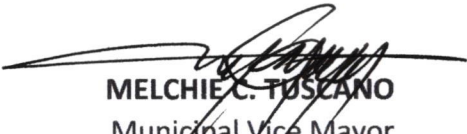
