AFFIRMING ORDINANCE NO. 21-2026 DATED JUNE 15, 2026 OF THE MUNICIPALITY OF CANTILAN, THIS PROVINCE ENTITLED "AN ORDINANCE AMENDING ORINANCE NO. 6-2003 ENTITLED "AN ORDINANCE IMPOSING 11:00 P.M. TO 4:00 A.M. CURFEW HOURS ON MINORS TO PROTECT THEM FROM HARM OR ANY FORM OF ATTACK THAT MAY RESULT TO INJURY TO THEIR PERSON BY ANYBODY WHOSE TARGETS ARE MINORS", BY PROVIDING ADDITIONAL REGULATIONS ON BUSINESS OPERATING HOURS, NOISE CONTROL, AND RELATED MATTERS", IT BEING WITHIN THE SCOPE OF THE PRESCRIBED POWERS OF THE SANGGUNANG BAYAN CONCERNED TO ENACT SUCH ORDINANCE PURSUANT TO THE LOCAL GOVERNMENT CODE OF 1991

(a) No. 1 (i) of the Local Government Code of 1991 provides that, "the sangguniang panlalawigan shall review all ordinances approved by the sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the sanggunian and of the mayor";

WHEREAS, Ordinance No. 21-2026 dated June 15, 2026 of the Municipality of Cantilan, this Province entitled "An Ordinance Amending Ordinance No. 6-2003 Entitled "An Ordinance Imposing 11:00 P.M. to 4:00 A.M. Curfew Hours on Minors to Protect Them from Harm or Any Form of Attack that May Result to Injury to their Person by Anybody Whose Targets are Minors", by Providing Additional Regulations on Business Operating Hours, Noise Control, and Related Matters", was submitted to this Body for review and same was referred to the Committees on Peace and Order, Public Safety, and Anti-illegal Drugs (Lead Committee)/Laws and Justice and Human Rights, for appropriate action;

WHEREAS, after a careful review by the Committees to which the matter was referred to, it was found out that it is within the ambit of the provisions of the Local Government Code of 1991;

WHEREAS, in view of the foregoing and on motion of _____ and jointly seconded by _____ and _____;

NOW THEREFORE

BE IT RESOLVED by the Sangguniang Panlalawigan of Surigao del Sur to affirm Ordinance No. 21-2026 dated June 15, 2026 of the Municipality of Cantilan, this Province entitled "An Ordinance Amending Ordinance No. 6-2003 Entitled "An Ordinance Imposing 11:00 P.M. to 4:00 A.M. Curfew Hours on Minors to Protect Them from Harm or Any Form of Attack that may Result to Injury to their Person by Anybody whose Targets are Minors", by Providing Additional Regulations on Business Operating Hours, Noise Control, and Related Matters", it being within the scope of the prescribed powers of the Sangguniang Bayan concerned pursuant to enact such Ordinance to the Local Government Code of 1991.
