AFFIRMING ORDINANCE NO. 14 DATED JULY 7, 2026 OF THE MUNICIPALITY OF LIANGA, THIS PROVINCE ENTITLED "AN ORDINANCE ESTABLISHING THE FOOD TOURISM HUB, PRESCRIBING GUIDELINES FOR THE USE, MANAGEMENT, AND OPERATION, SETTING RENTAL RATES, AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF", IT BEING WITHIN THE SCOPE OF THE PRESCRIBED POWERS OF THE SANGGUNIAN BAYAN CONCERNED PURSUANT TO THE LOCAL GOVERNMENT CODE OF 1991

(a) No. 1 (i) of the Local Government Code of 1991 provides that, "the sangguniang panlalawigan shall review all ordinances approved by the sanggunians of component cities and municipalities and executive orders issued by the mayors of said component units to determine whether these are within the scope of the prescribed powers of the sanggunian and of the mayor";

WHEREAS, Ordinance No. 14 dated July 7, 2026 of the Municipality of Lianga, this Province entitled "An Ordinance Establishing the Food Tourism Hub, Prescribing Guidelines for the Use, Management, and Operation, Setting Rental Rates, and Providing Penalties for Violations Thereof", was submitted to this Body for review and same was referred to the Committees on Health, Sanitation and Nutrition (Lead Committee) Ways and Means and Taxation, for appropriate action;

WHEREAS, after a careful review by the Committees to which the matter was referred to, it was found out that it is within the ambit of the provisions of the Local Government Code of 1991;
