EXPLANATORY NOTE

Section 76 of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991", mandates local government units (LGUs) to undertake periodic review and adjustment of their organizational structure and staffing pattern to promote efficiency, economy, and responsiveness in local governance. Section 447 of the same Code empowers the Sangguniang Bayan to determine the positions and the salaries, wages, allowances, and other emoluments of officials and employees paid wholly or mainly from municipal funds. Upon evaluation and assessment of the plantilla positions of the Municipality of Madrid, certain positions have been found to be long-vacant and/or no longer consistent with the current needs and priorities of the LGU. The abolition of such position is necessary to streamline operations, enhance efficiency,



and allow for the reallocation of Personal Services (PS) savings to more relevant plantilla positions that address the municipality's service delivery mandates and institutional priorities.

**BE IT ORDAINED** by the Sangguniang Bayan of the Municipality of Madrid, Province of Surigao del Sur, that:

**SECTION 1. ABOLITION OF THE POSITION.** The plantilla position of Medical Technologist I (Plantilla No. 5, Salary Grade 11, Basic Salary of ₱28,512.00) under the Municipal Health Office of the Municipal Government of Madrid is hereby abolished.

**SECTION 2. SEPARABILITY CLAUSE.** If any provision of this Ordinance is found to be inconsistent with any law, other provisions or part/s thereof not so affected shall remain in full force and effect.

**SECTION 3. REPEALING CLAUSE.** All Ordinances, Rules and Regulations or parts thereof, in conflict with, or contrary to, the Provisions of this Ordinance not so affected herewith are hereby repealed or modified accordingly.

**SECTION 4. EFFECTIVITY.** This ordinance shall take effect immediately upon approval.

**ENACTED:** this 28<sup>th</sup> day of July, 2026, in the Municipality of Madrid, Surigao del Sur.

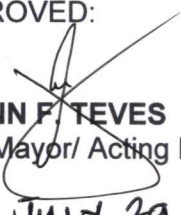
