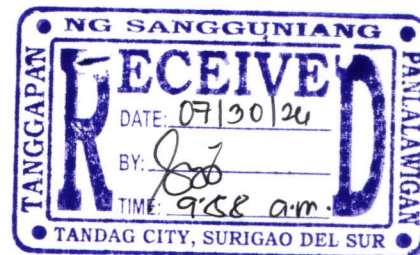

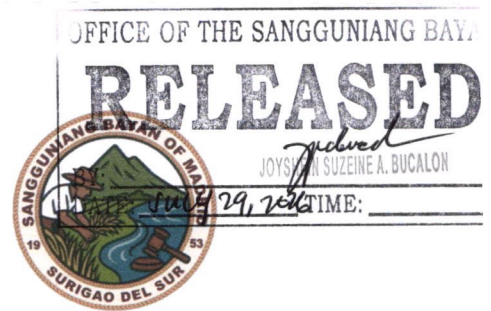

RESOLUTION NO.180-26

“A RESOLUTION FORMALLY ACCEPTING THE IRREVOCABLE RESIGNATION OF HONORABLE JOCILLE D. URIARTE AS MEMBER OF THE SANGGUNIANG BAYAN OF MADRID, SURIGAO DEL SUR, AND OFFICIALLY DECLARING HER COUNCIL SEAT VACANT EFFECTIVE AUGUST 1, 2026.”

WHEREAS, Honorable Jocille D. Uriarte, an elected Member of the Sangguniang Bayan of Madrid, Surigao del Sur, formally submitted her written letter of resignation dated July 27, 2026, tendering her irrevocable resignation from her position effective July 31, 2026, to pursue another opportunity to continue serving the Municipality in a different capacity;

WHEREAS, the official letter of resignation was received by the Office of the Sangguniang Bayan on July 27, 2026, and officially brought before the body for appropriate legislative action;

WHEREAS, during the consideration of the matter, the Sangguniang Bayan thoroughly deliberated on the resignation and unanimously accepted the irrevocable resignation of Hon. Jocille D. Uriarte by all members present;

WHEREAS, pursuant to the pertinent provisions of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the resignation of a local elective official creates a permanent vacancy in the council that must be officially declared to facilitate the subsequent filling of the vacancy in accordance with law;

WHEREAS, the resignation takes effect on July 31, 2026, thereby rendering her council seat vacant starting August 1, 2026;



NOW, THEREFORE, on motion of Hon. April Grace A. Mata, duly seconded by all members present, be it:

BE IT RESOLVED, as it is hereby resolved by the **Sangguniang Bayan of Madrid, Surigao del Sur**, in session assembled, to formally accept, as it hereby **unanimously accepts** the irrevocable resignation of **Honorable Jocille D. Uriarte** as Member of the Sangguniang Bayan, effective July 31, 2026;

RESOLVED FURTHER, to officially declare her council seat **VACANT** effective **August 1, 2026**;

RESOLVED FINALLY, that copies of this Resolution be furnished to Hon. Jocille D. Uriarte, the Local Chief Executive Hon. Juan Paolo L. Lopez, the Office of the Provincial Governor, the office of the Vice Governor, the Sangguniang Panlalawigan Members, the Municipal Local Government Operations Officer (MLGOO) Ms. Lady Ella C. Chu, the Human Resource Management Officer I Ms. Rechie B. Tuldanes, and other concerned offices for information, guidance, and appropriate action.
