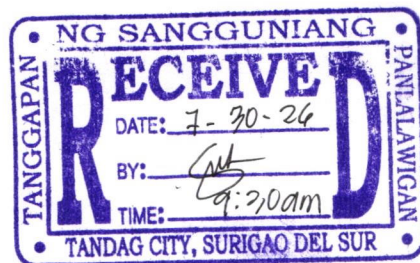

WHEREAS, the Sangguniang Panlalawigan of Surigao del Sur enacted **SP Resolution No. 1216-26, Series of 2026 - requesting all City/Municipal Social Welfare and Development Offices within the Province to adopt a temporary and flexible policy authorizing the personnel-in-charge to recognize and accept any valid government-issued identification sufficient to reliably establish the identity of benefit claimants pending the issuance of the final policy guidelines by the Department of Social Welfare and Development (DSWD) Central Office**;

WHEREAS, the Sangguniang Bayan of Barobo recognizes the need to ensure the uninterrupted delivery of social welfare services and benefits, particularly to qualified beneficiaries who, due to circumstances beyond their control, are unable to present the required identification documents;

WHEREAS, adopting the initiative embodied in the aforesaid Provincial Resolution will help facilitate the efficient delivery of services while maintaining proper verification and accountability measures until such time that the DSWD Central Office issues its final policy guidelines.

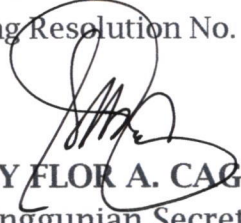
