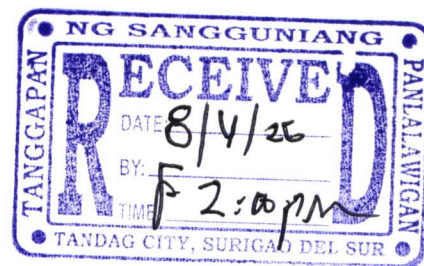

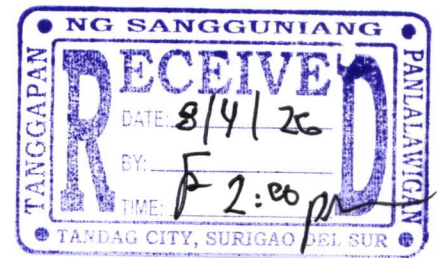

WHEREAS, Section 447 (a)(2)(i) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that the Sangguniang Bayan shall approve the annual and supplemental investment programs of the municipal government and appropriate funds for their implementation, in reference to the general welfare of its inhabitants;

WHEREAS, Section 336 of R.A. 7160 provides for the utilization of savings and unexpended balances, and makes them available for expenditure to augment any item in the approved annual budget upon enactment of an appropriate ordinance;

WHEREAS, the Municipal Development Council (MDC) Executive Committee passed MDC-Executive Committee Resolution No. 03, Series of 2026, adopting and endorsing to the Sangguniang Bayan the inclusion of priority Programs, Projects, and Activities (PPAs) under the Executive and Engineering Services into the CY 2026 Supplemental Annual Investment Program (SAIP) No. 03;

WHEREAS, the identified PPAs under the Executive and Engineering Services are to be funded from savings generated from the General Fund-Personal Services for the period covering January to June 2026, and reprogrammed 20% Development Fund in the total amount of Two Million Six Hundred Eighty-One Thousand One Hundred-Eighty Pesos and Seventy-Two Centavos Only (₱ 2,681,180.72);

WHEREAS, the identified PPAs are crucial for the efficient delivery of municipal services and public infrastructure improvements within the municipality;

WHEREAS, upon careful review and evaluation by the August Body, the proposed Supplemental Annual Investment Program No. 03, Series of 2026, was found to be in full compliance with existing budgeting, accounting, and local development planning guidelines;

WHEREAS, in view of the foregoing and on motion of Hon. Nicholson Y. Lozada, duly seconded by all Sangguniang Bayan Members present;

NOW, THEREFORE:

BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the Sangguniang Bayan in session assembled, to ADOPT and APPROVE the Supplemental Annual Investment Program (SAIP) No. 03, Series of 2026, under MDC-Executive Committee Resolution No. 03, Series of 2026, for the Executive and Engineering Services in the total amount of ₱ 2,681,180.72, for its intended purpose;
