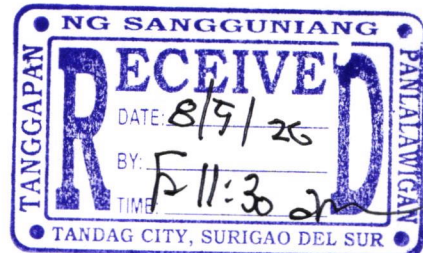

WHEREAS, there exists a long-standing boundary dispute between the City of Bislig, Province of Surigao del Sur, and the Province of Agusan del Sur, specifically involving the Municipalities of Trento, Bunawan, and Rosario;

WHEREAS, this unresolved territorial boundary dispute continues to pose significant challenges to local governance, including clarity on political jurisdiction, land administration, real property tax collection, the delivery of essential basic services, and peace and order in the affected border barangays and communities;

WHEREAS, the Sangguniang Panlungsod of Bislig City deemed it proper to recognize the crucial role of the Provincial Government of Surigao del Sur in negotiating, mediating, and pursuing a fair and lawful resolution to this boundary dispute in order to obtain an official, comprehensive update on the progress and bilateral agreements vital to properly align local development programs and legislative measures;

NOW THEREFORE, BE IT, -

RESOLVED, AS IT IS HEREBY RESOLVED, to request the Governor, Honorable Johnny T. Pimentel, through the Sangguniang Panlalawigan of Surigao del Sur to update the Sangguniang Panlungsod of Bislig City on the status of the settlement of boundary dispute between the Provinces of Agusan del Sur and Surigao del Sur, particularly the affected areas of Bislig City and the Municipalities of Trento, Bunawan and Rosario.
