

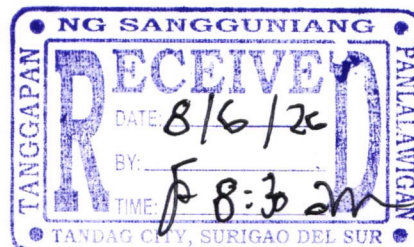

Dear **Vice Governor Alameda**:

This refers to the Surigao del Sur Sangguniang Panlalawigan's (SP) email on July 28, 2026, forwarding a copy of SP Resolution No. 1453, Series of 2026, "A Resolution Favorably Endorsing to the Caraga Regional Development Council (RDC) the Proposed Infrastructure Projects of the 1st District Engineering Office (DEO) - Department of Public Works and Highways (DPWH) of the Province of Surigao del Sur for Funding Support for Fiscal Year (FY) 2027."

May we respectfully inform the good Acting Governor that the Caraga RDC's review and endorsement of the FY 2027 agency budget proposals, including the DPWH Caraga, were already concluded in March 2026.

Relative to this, we have forwarded the abovementioned resolution to the DPWH Regional Office XIII to verify whether the projects listed in the resolution have been included in their FY 2027 budget proposal, the Revalidated/Updated FY 2027 Programs and Projects (PAPs) of the Caraga Regional Development Investment Program (RDIP) and FY 2027-2029 Three-Year Rolling Infrastructure Program (TRIP). For projects not yet reflected in the RDIP/TRIP, the said agency was requested to coordinate directly with your good Office to discuss its enrollment in the RDIP/TRIP under appropriate implementation year, subject to implementation readiness and program requirements.

Furthermore, for projects proposed for implementation in the succeeding years, we recommend that your good Office submit them to the DPWH Surigao del Sur DEOs — for onward submission to the DPWH Regional Office XIII at least two years prior to target implementation year. This timeline is consistent with the RDIP/TRIP updating cycle, which is undertaken two years prior to the intended year of implementation. This updated list of priority projects serves as a key reference in the preparation and deliberation of the DPWH Regional Office XIII's budget proposal, which is conducted one year prior to its target implementation year.

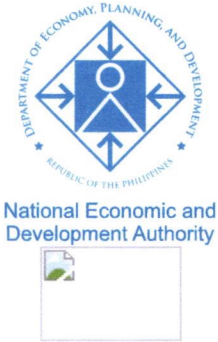
