A RESOLUTION ENDORSING TO THE SANGGUNIANG BAYAN THE PROPOSED PROGRAMS/PROJECTS/ACTIVITIES IN THE ANNUAL INVESTMENT PROGRAM (AIP) – SUPPLEMENTAL NO. 2 FOR CY 2026 OF THE MUNICIPALITY OF SAN AGUSTIN AMOUNTING TO PHP 5,200,000.00 FOR ITS ADOPTION.

WHEREAS, it is the responsibility and priority concern of every Local Chief Executive and Punong Barangays to ensure that the local funds are optimally utilized to help achieve desirable socio-economic development and environmental outcomes;

WHEREAS, one of the key responsibilities of the Local Government Unit is to provide essential services and facilities to its constituents, including healthcare, infrastructure, other vital systems and facilities, while ensuring that local funds are efficiently utilized to achieve positive socio-economic development and environmental outcomes;

WHEREAS, during the Municipal Resilience Team (MResT) meeting, it was established that the counterpart fund amounting to Four Million Seven Hundred Thousand Pesos (PHP 4,700,000.00) will remain unutilized for the current fiscal year due to ongoing social preparation and project identification activities until December;

WHEREAS, the aforementioned amount is allocated under the 20% Local Development Fund (LDF), and failure to execute these funds within the current fiscal year will adversely impact the LDF Utilization Accomplishment Report—a crucial indicator for the Seal of Good Local Governance (SGLG);

WHEREAS, the August Body agreed to reallocate the said amount toward the proposed Improvement of the Municipal Water System to expand coverage, extend service connections to unserved households, and enhance overall water utility delivery;

WHEREAS, the Municipal Disaster Risk Reduction and Management Council (MDRRMC) issued Resolution No. 02, Series of 2026, entitled "*A Resolution Approving the Revised Continuing Local Disaster Risk Reduction and Management Fund Investment Plan (LDRRMFIP) CY 2026 of the Municipality of San Agustin*";

WHEREAS, the said resolution approved the amendment of the project title from "*Installation of Solar Light at Multi-Hazard Prone Area*" to "*Provision of Renewable Energy-Based Electrification to Temporary Shelters During Calamities*";

WHEREAS, the MDRRMC formally endorsed the revised LDRRMFIP to the Municipal Development Council (MDC) for further endorsement to the Sangguniang Bayan for its adoption;

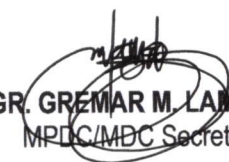
NOW THEREFORE, on motion presented by Hon. Celso L. Salamanca, duly seconded by all members present, it was:

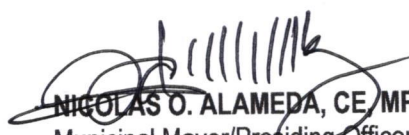

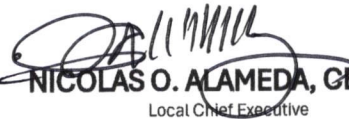
